Report of the Committee on Publications To The Executive Committee and the Board of Trustees of ASOR Submitted by Jeffrey A. Blakely, Vice-President 11 November 2008

In the six months since the May Trustee Meeting in Philadelphia there has been progress in many aspects of publications. The credit for these successes in publications rests with the good work of our editors and with our Interim Vice-President of Publications, Joe Greene, who oversaw much of this work during the summer. My report will be divided into three parts: current status, issues facing COP, and action items coming from COP. There is also an appendix, the complete reports of the various editors of ASOR publications.

Current Status:

BASOR, edited by James M. Weinstein.

BASOR 351 (August 2008): Came out in late October.

Issues Facing Publications:

This is the end of the editorial terms of Nancy Serwint, editor of the *ASOR Annual*, and of Joseph A. Greene, editor of the Archaeological Report Series. Each has spent six years editing their series on behalf of ASOR. The Committee on Publications and ASOR owe these individuals their most hearty thanks and deep appreciation for their time and efforts these past years. As of 1 January 2009 Joseph A. Greene will become editor of the *ASOR Annual* and Kevin M. McGeough will become editor of the Archaeological Report Series, each serving an initial three-year term. We expect a smooth transition.

In the past year great progress has been made in getting our journals caught up. We are almost there. At the current time *NEA* is about four weeks behind, *BASOR* about four weeks behind, and *JCS* about four months behind. It is expected that both *NEA* and *BASOR* will be on time by March, 2009.

During this past year a cost test was conducted to determine the marginal costs of potential upgrades (e.g., color and more pages) to **BASOR**. The costs are not yet fully tabulated, but these numbers will be used in the budgeting process for **BASOR** next year. The Executive Director has prepared a report detailing these expenses. As more data come in this report will be updated and be placed on file in the Boston Office.

With *NEA* now being close to caught up, we have been able to bill our subscribing individuals and institutions for future issues. What we are experiencing is a drop in such subscriptions. Undoubtedly part of this is institutions not wanting to pay for the same journal twice in one fiscal year, but the drop may also reflect some aspect of a shift in college libraries from paper to electronic subscriptions to journals. It may also be a continuing impact of the name change from *BA* to *NEA*. COP will be discussing this in Boston.

It has been a number of years since ASOR sought bids for printing all of its journals and books. It is the belief of the Executive Director and the Vice-President for Publications that we should be seeking such bids over the next few months, preferably before the next

budgeting cycle. The Executive Director, Vice-President for Publications, and journal editors of ASOR plan to meet with at least one potential bidder in Boston.

The Vice-President for Publications has struck an ad hoc committee within COP to practice prophecy and to suggest a variety of ideas regarding how ASOR might move publications into the vanguard of the electronic age. These ideas will be reported to COP for discussion and a recommendation. Based on those discussions a report will be prepared for discussion by the EC and the Board.

The Executive Director recently attended a conference in Detroit. One topic discussed was "libel tourism." The Executive Director will be presenting these issues to COP in Boston. COP will be discussing how ASOR can be better prepared to defend itself against potential libel suits.

Eric Meyers, Tim Harrison, Andy Vaughn, and Jeff Blakely have been in contact with Oxford University Press about updating *OEANE*. I suggest that any discussion of this topic be led by Eric Meyers.

The Vice-President for Publications has begun the process of reorganizing COP. The first issue being addressed is identifying and assigning all tasks that need to be completed in order to publish each of ASOR's publications. With a better understanding of these tasks the job descriptions for those working on publications can be modified to reflect reality. Discussions between the President and the Vice-President for Publications suggested that the reorganization plan for COP be presented to the EC and Board as one integrated document and not as a series of piecemeal changes.

The current financial downturn has cut into the reserves in the Opportunity Fund. The financial report of the Opportunity Fund is included in the Treasurer's Report. In addition, COP will probably discuss improving the scheduling on publications that need subventions so that large shifts in the balances of the Opportunity Fund are minimized.

COP also has planned to discuss unifying the standards for illustrations in all ASOR publications.

Action Items:

Item 1. COP moves that Mitch Allen be confirmed to serve a second three-year term as a COP member of the Class of 2011.

Item 2. COP moves that Christopher Rollston, Jane Cahill West, and Bill Schniedewind be confirmed to serve a four-year term on the *BASOR* Editorial Board, 2009-2012.

Item 3: COP moves that Gabriele Fassbeck and Jennie Ebeling be confirmed to serve as Assistant Editors of *NEA*.
