I lead research and development on scholarly communications and data sharing systems for the humanities and social sciences. My efforts focus on *Open Context*, a data publication system for archaeology and related disciplines. The National Science Foundation (NSF), the US Department of State, and the National Endowment for the Humanities (NEH) link to Open Context as a data repository for NSF and NEH grant data management. In addition to serving the needs of the archaeological community, I have adapted versions of *Open Context* to demonstrate public health applications with the UC Berkeley School of Public Health. I am actively involved in Linked Open Data efforts to promote greater interdisciplinary data sharing and collaboration. I have participated in data archiving and sharing policy-making efforts and currently advise archaeological data management programs in the US, Europe and Australia. I joined the Board of the Shelby White and Leon Levy Program for Archaeological Publications, a granting program annually awarding roughly \$1 million for archaeological publication projects.

In June 2013, President Obama recognized me as a "Champion of Change" in promoting Open Science.
